**SUBJECT: REACH Conformity Declaration.**

\*\*\*\*\*  
Regulation (EC) 1907/2006 ("REACH") requires producers or importers of chemical substances to provide European Chemicals Agency (ECHA) the data on these substances.

Vinavil S.p.A. is a producer of polymers and polymer-based mixtures (such as our product **Vinavil SA**), and these products are not subject to registration according REACH Regulation Article 2 (9): then our products have no registration number.

Substances which met the requirements of the terms covered by REACH (November 30th, 2010, and May 31st, 2013) were previously successfully registered. Regarding the last REACH deadline of May 31st, 2018, we confirm that all relevant substances supplied to us as such or in mixtures (including starting substances for polymers) have been registered by our suppliers (eventually by their suppliers) or are exempt from registration. For polymers, which are exempt from registration under REACH, the reactants and monomers they are based upon have been registered or are exempt.

It should also be noted that substances exempted from registration by Annex IV or V of REACH will have no registration number.


Moreover, all the substances that fall under the regulation of the notification were notified according to Regulation 1272/2008 (CLP) on Classification, Labelling and packaging of substances and mixtures.

With regard to these facts, we would underline that the products you purchased from us (**Vinavil SA** and **EVA 04**) are polymer-based mixtures not classified dangerous according to present European Regulation. Consequently, NOT classified polymers or polymer-based mixtures do not require exposure scenario preparation and information transfer along the supply chain as well as use descriptors are not relevant.

Our above-mentioned products comply with art. 59 (1) of the Regulation 1907/2006 as they do not contain any SVHC (Substances of Very High Concern defined according to criteria established by art. 57) included in the "candidate list" for the authorization in a concentration higher than 0,1% (last update 14<sup>th</sup> June 2023).
